## General Terms & Conditions for the supply of products and services of the KNIEF & CO. GmbH for Commercial transactions between businesses

PRICELIST 2017



### I. General Provisions

1. All legal relations between the Knief & Co GmbH (hereinafter referred to as „KCO“) and its contract partners in connection with supplies and / or services as well as offers of KCO shall be solely governed by these General Terms and Conditions. All contracts, KCO closes with its contract partners (hereinafter referred to as „Customer“) on the goods and services offered by KCO shall be subject to these General Terms and Conditions.

2. These General Terms and Conditions shall also apply to all future deliveries, services or offers to the Customer, even if they are not specifically agreed to again.

3. Terms and Conditions of the Customer or third parties are only valid insofar as KCO has expressly agreed to them in writing, regardless of whether the Customers' orders are executed without reservation.

### II. Offer and Conclusion of Contract

1. All offers of KCO are non-binding and noncommittal, unless they are explicitly marked as binding or contain a specific acceptance period. Otherwise, the contract only comes into effect if KCO provides the Customer with written confirmation in relation to the order or a delivery within two weeks after receiving the order.

2. The legal relationship between KCO and the Customer is governed by the written contract or the written confirmation of the order, upto and including these General Terms and Conditions. Oral arrangements are legally non-binding.

3. No variation or addition to the contract or to these General Terms and Conditions shall be binding unless confirmed in writing and signed by one of the CEO's of KCO. Other employees or agents of KCO are not authorized to make agreements differing from the written contract or from these General Terms and Conditions.

4. To comply with the written form, the transmission by means of telecommunications, in particular by fax or e-mail, is sufficient if a copy of the signed statement is sent to the other contract party.

5. Unless otherwise agreed in writing, all documentation of the supply items and services (for example, dimensions, weight, loading capacities, tolerances, composition) as well as the illustrations and drawings thereof are only approximations so long as it has not been stipulated in the contract that exact details are required. They are not guaranteed characteristics, but a description or labelling of the delivery. KCO reserves the right to make any changes to the specifications of the supplies which are required to conform to any applicable statutory requirements or which include technical improvements, which do not materially affect their quality of performance.

### III. Prices, payment and offsets.

1. All prices are quoted in Euro and given on an ex works basis, unless agreed otherwise. The Customer shall be liable to pay the VAT at the rate and in the manner from time to time prescribed by law. For export deliveries the currently valid „INCOTERMS“ apply.

2. Except as otherwise agreed in writing, the Customer shall be liable to pay KCO's charges for transport.

3. Unless quoted as a fixed price in writing, all prices are subject to the list price in force at the time of supply, or subject to individual agreements.

4. Payments shall be made in full to KCO's accounting department without any deduction. The day of payment is deemed to be the day the money is credited to KCO's accounts. A payment shall only be deemed to have been made when KCO has disposal over the amount. Unless otherwise agreed in writing, cheques and bills of exchange only apply as payment when honoured immediately after receipt of the invoice. All bank transaction costs shall be immediately borne by the Customer. If the Customer fails to make any payment on the due date then KCO shall be entitled to charge the Customer interest on the amount unpaid at the rate of 5% from the due date until payment is made in full. In case of default, the possibility to claim higher interest rates and additional damages shall remain unaffected.

5. Regardless of other terms, payments are initially set off against costs, then against interest and then used to settle the oldest principal debt.

6. The Customer may only offset payments against any money owing from KCO if its claims are undisputed or legally valid. The Customer has a right of retention of payment only as long as the counterclaim is based on the same contractual relationship and insofar as KCO does not hold a security, e.g a bank guarantee.

7. If KCO in its reasonable opinion determines after concluding a contract that the Customer's credit worthiness is unsatisfactory, KCO reserves the right to demand immediate payment or collateral security. KCO shall be entitled to withdraw from the contract or to suspend any further deliveries. In this case the Customer has no claim for damage. If the Customer fails to make a payment or, in the case of its filing for insolvency, all invoices become due immediately.

### IV. Delivery

1. Deliveries shall be at the discretion of KCO ex-works of KCO.

2. Unless otherwise expressly agreed in writing, dates and deadlines for deliveries and services are non-binding. If shipping has been agreed, the delivery deadlines and dates refer to the moment of transfer to the shipper, carrier or other contracted third party transporter. 3. If the Customer does not fulfill its obligations under the contract in time, times set shall be extended reasonably.

4. In non-observance of the times set is due to:

- force majeure,
- any other unforeseen event (such as breakdowns of all kinds, energy shortages, strikes, lawful lockouts),
- hindrances attributable to German or otherwise applicable rules at KCO or at one of its suppliers, such times set shall be extended accordingly, plus a reasonable lead time. Where there is a hindrance according to points 4a) to 4c) which makes the delivery fundamentally more difficult or impossible and as long as the hindrance is not of a temporary nature only, KCO and the Customer are entitled to rescind the contract. In such cases the Customer has no claim for damages. In other circumstances of transgressions of deadlines, the Customer will give KCO a reasonable extension of time for delivery beginning with the day of the incoming mail of the written notification regarding the period of delivery having been exceeded.

5. Partial deliveries are permissible at any time, provided

- this is reasonable for the customer as part of the contractual purpose,
- the Customer does not incur significant additional own expenses or costs to third parties, unless KCO agrees to assume these costs.

### V. Loading, shipping, packaging, insurance

1. Loading and shipping shall be at the risk of the Customer.

2. KCO shall be free to determine the mode of shipment and the packaging at its reasonable discretion. KCO shall endeavor to take the Customer's preferences and interests into consideration as regards the mode of packaging and of the shipping route.

3. KCO shall not take back any transport or other packaging in accordance with the German Packaging Ordinance. The Customer is obliged to dispose of packaging at its own expense.

4. Only upon the Customer's request, KCO shall insure the delivery against risks and at the Customer's expense.

5. The risk of shipment shall be borne by the Customer, unless in the case of a compulsory redemption due to legal or contractual obligations of KCO.

### VI. Transfer of Risk

1. The risk shall pass to the Customer as soon as the goods have been shipped or collected by the carrier, freight forwarder or otherwise agreed third party shipper. The handover of the dispatch person is effective with the commencement of the loading operations. This applies even for partial deliveries or if KCO carries out other services (for example, transport).

If the dispatch or delivery is delayed for reasons for which the Customer is responsible, the risk shall pass to the Customer on the day at which the delivery item is ready for dispatch or delivery and KCO has informed the Customer as such.

2. Storage costs after transfer of risk shall be borne by the Customer.

3. The Customer is obliged to inspect the Supplies immediately upon delivery and shall notify the carrier of any loss or damages. Such notification shall be certified from the carrier on the consignment note or any other relevant document and shall be sent to KCO within 2 days after notification.

### VII. Warranty

1. The warranty period shall be two years upon delivery or, if acceptance is required, from acceptance onwards. This shall not apply to Customer's claims of damages based on damages of loss of life, bodily injury or health, and an intentionally or grossly negligent breach of contract on the part of KCO or its agents; in this cases they expire in accordance with the statutory provisions.

2. There shall be no warranty as long as the repair of defects becomes impossible or unacceptably difficult if the customer or a third party modifies or repairs the delivered Supplies without the consent of KCO, and in the case of faulty or negligent handling, improper storage and maintenance. If a remedy of defects is nonetheless acceptable, the Customer shall be responsible for additional costs.

3. The supply of used items agreed with the Customer in individual cases is done under exclusion of any warranty.

### VIII. Defects

1. Ceramic, Acrylic and/or Solid Surface materials can contain crazes and color deviations. Furthermore, non-prime products can contain imperfections at the edges or on the surfaces. Such phenomena does not affect the value of the materials and do not constitute a defect. For natural materials, e.g. marble or natural stone in general, KCO shall be under no liability whatsoever in respect of variations in color, glass veins, hairline cracking and similar deviations of the material.

2. KCO's deliveries of bathtubs and shower trays made of sanitary acrylic and all K | STONE Solid Surface products meet the relevant technical requirements, arising from the CE conformity.

3. The delivery item must be carefully inspected immediately after delivery to the Customer or to a specific third party from him. KCO shall not be responsible for any obvious defects, any shortage, damage or discrepancy in Supplies that would have been recognized on an immediate, thorough investigation unless notified to KCO in writing within 5 working days of receipt of the Supplies by the Customer.

With regard to other significant defects, the delivered Supplies shall be deemed approved by the Customer if the notification was not given within 5 working days after the Customer became aware of the defect or could reasonably be expected to have become aware of the defect if the defect was in normal use for the Customer detectable at an earlier date. The Customer shall not refuse acceptance of Supplies due to insignificant defects.

The redemption of faultless Supplies can only be accepted after a previous written confirmation of KCO. KCO shall credit the Customer the amount of the invoice minus 30% of the net amount for examination and handling costs and the loss of profit.

4. Upon request of KCO, a contested KCO delivery item has to be returned carriage paid to KCO. If the notice of defect is justified, KCO shall reimburse the costs of the cheapest method of shipment. The Customer shall have no claim with respect to the extent that expenses are increased because the Supplies have been brought to another location than that of the intended use.

5. At its free discretion within a reasonable period of time, KCO shall be given the choice to repair or to replace the defective goods two times. If repair or replacement is unsuccessful, the Customer is entitled to rescind the contract or reasonably reduce the remuneration unless further attempts of rework are reasonable for both parties. The Customer shall have no claim if statutory provisions allow KCO to refuse reworks.

6. If KCO replaces items in compliance with its obligations, the replaced items become the property of KCO when they are removed or returned.

7. If KCO is to blame for a defect and for the failure of the repair, the Customer may demand compensation under the circumstances stipulated in clause X.

8. In case of defects of components of other manufacturers which KCO cannot remedy for reasons of licensing law or for factual reasons, KCO can choose between enforcing claims against the manufacturer and supplier on the account of the Customer or assigning these claims to the Customer. Claims against KCO exist only if the legal enforcement of the abovementioned claims against the manufacturer or the supplier was unsuccessful or hopeless, e.g. in the case of insolvency.

### IX. Industrial Property Rights and copyrights; Defects in Title

1. Unless otherwise agreed between the parties, KCO shall provide the Supplies free from third parties' industrial property rights and copyrights with respect to the country of the place of delivery only.

2. In case of infringements of rights concerning Supplies delivered by KCO and which are from other manufacturers and upstream suppliers point VIII 7 and 8 shall apply mutatis mutandis.

### X. Claims for damages

1. KCO is liable according to the mandatory statutory provisions if the customer asserts claims for damages based on intent or gross negligence, for guaranteed characteristics, for loss of life, bodily injury or damage of health.

2. KCO is not liable in cases of simple negligence by its corporate bodies, lawful representatives, salaried employees or other agents as long as there is no breach of an essential contractual obligation. An essential contractual obligation is an obligation on which the client

can and may rely. Essential contractual obligations include the obligation to deliver in a timely manner goods that are free of defects with regards to the conformity and suitability of use, legal deficiencies, advisory, protective, custodial and duty of care obligations that enable the client to use the item delivered in the contractually prescribed manner or whose purpose is to protect the lives and health of the client's personnel or the protection of his property from significant damage.

3. Claims for damages shall be limited to the foreseeable damage which is intrinsic to the contract, provided that no case of intent applies. KCO shall only be liable for indirect and consequential damages arising from or in connection with its performance under the contract if they were typically foreseeable.

4. The above exclusions and limitations of liability also apply to the same extent in favor of the corporate bodies, employees and other agents of KCO.

5. In so far as KCO provides technical information or acts as an adviser and this information or advice is not part of the contractually agreed scope of services offered by him, this is done free of charge and with the exclusion of any liability.

6. Unless otherwise provided for in the present General Terms and Conditions, the Customer has no claim for damages based on whatever legal reason.

### XI. Retention of Title

1. The items pertaining to the Supplies ("Retained Goods") shall remain KCO's property until each and every claim KCO has against the Customer on account of the business relationship has been fulfilled. If the combined value of KCO's security interests exceeds the value of all secured claims by more than 20%, KCO shall release a corresponding part of the security interest if so requested by the Customer; KCO shall be entitled to choose which security interest it wishes to release.

2. For the duration of the retention of title, the Customer may not pledge the Retained Goods or use them as security.

3. Should the Customer resell Retained Goods, he hereby by way of security assigns to KCO his future claims under the resale including any ancillary rights and all balance claims against his customer without the need for subsequent special statements. If the Customer resells the Retained Goods together with other items without an individual price having been agreed, the Customer shall assign to KCO that portion of the total price which equals the price of the Retained Goods invoiced by KCO.

4. The Customer is entitled to process, amalgamate or combine the Retained Goods with other items. Processing is made for KCO. The Customer shall store the new item thus created for KCO, exercising the due care of a diligent business person. The new items are considered as Retained Goods.

KCO and the Customer agree that the Retained Goods which may be combined or amalgamated with other items that were not the property of KCO, now become co-owned by KCO. The share of co-ownership by KCO results from the ratio of the original Retained Goods to the value of the other goods at the time of blending or mixing. In this respect, the new items are considered as Retained Goods.

The provisions on the assignment of claims according to point 3 above shall also apply to the new item. The assignment, however, shall only apply to the amount corresponding to the value invoiced by KCO for the Retained Goods that have been processed, combined or amalgamated.

Where the Customer combines Retained Goods with real estate or movable goods, he shall, without any further declaration being necessary to this effect, also assign to KCO as security his claim to consideration for the combination, including all collateral rights for the prorata amount of the value the combined Retained Goods have on the other combined items at the time of the combination.

5. Until further notice the Customer may collect assigned claims relating to the resale. KCO is entitled to withdraw the Customer's permission to collect funds for good reason. In addition, KCO may, upon expiry of an adequate period of notice disclose the assignment,

realize the claims assigned and demand that the Customer informs its customers of the assignment.

6. The Customer shall inform KCO forthwith of any seizure or other act of intervention by third parties. If a reasonable interest can be proven, the Customer shall, without undue delay, provide KCO with the information and/or Documents necessary to assert the claims it has against its customers.

7. Where the Customer fails to fulfill its duties, e.g. defaults on payments, KCO shall be entitled to rescind the contract and take back the Retained Goods in the case of continued failure following expiry of a reasonable remedy period set by KCO. The statutory provisions providing that a remedy period is not needed shall be unaffected. The Customer shall be obliged to return the Retained Goods. The fact that KCO takes back Retained Goods and/or exercises the retention of title, or has the Retained Goods seized, shall not be construed to constitute a rescission of the contract, unless KCO so expressly declares.

### XII. Jurisdiction and applicable law

1. If the Customer is a businessman, or is a legal entity or a special fund organized under public law or has no general place of jurisdiction in Germany, the sole venue for all disputes arising directly or indirectly out of the contract shall be the corporate seat of KCO. However, KCO may also bring an action at the Customer's place of business.

2. The contract and its interpretation shall be governed only by German law. The United Nations Convention on Contracts for the International Sale of Goods dated 11 April 1980 (CISG) does not apply.

### XIII. Severability Clause

The contract and these General Terms and Conditions remain binding even if individual terms or provisions are void or unenforceable. In place of the invalid or unenforceable provision, or to fill a contractual gap, such valid and enforceable provision shall apply which reflects as closely as possible the commercial intention of the parties as regards the invalid, unenforceable or missing provision.

In case of discrepancies between different language versions of these General Terms and Conditions, the German language version shall take precedence.
